The Annual Appropriation Ordinance (Operating Budget) is passed the first quarter of each fiscal year which begins on May 1. The Village's sole office is located at 302 S. 2nd Street, Malta IL. 60150. Malta currently employs 8 part-time employees and 2 full-time employees.

Board Meetings are held on the second and fourth Wednesday of each month at 7:00 p.m. at Village Hall 302 S. Second Street, Malta IL. Citizens requesting to address the board may do so at 7:00 p.m. during Citizen's Hearing. Second meeting of the month is subject to cancellation.
